# **Qatar Creates x Pierre Gasly Helmet Design Competition - Terms and Conditions**

### 1. General

1.1. By entering the Qatar Creates x Pierre Gasly Helmet Design Competition (the "Competition"), participants agree to be bound by these Terms and Conditions.

1.2. The Competition is organized by Qatar Creates in collaboration with Pierre Gasly ("Organizers").

1.3. The Competition is open to individuals aged 18 years or older at the time of entry.

1.4. The Organizers reserve the right to modify or cancel the Competition at any time without prior notice.

#### 2. Entry Requirements

2.1. All entries must be submitted through the official Qatar Creates competition portal by the specified deadlines for each Grand Prix (Mexico GP: September 30th, Qatar GP: October 20th).

2.2. Each participant may submit up to one design per city, with a maximum of two submissions.

2.3. Entries must be the original work of the participant and must not have been previously published or entered into any other competition.

2.4. Designs specifications: **Digital** design for a racing helmet, considering shape and visibility. Versatile, with no obstruction to sponsor logos or driver visibility.

• Format: JPEG or PNG, not exceeding 100 MB. Open file may be requested.

2.5. Incomplete, late, or illegible submissions, or submissions that do not comply with these Terms and Conditions, may be disqualified at the discretion of the Organizers.

#### 3. Intellectual Property

3.1. By submitting a design, participants grant the Organizers a non-exclusive, worldwide, royalty-free license to use, reproduce, distribute, and publicly display the design in connection with the Competition and related promotional activities.

3.2. The participant retains ownership of the original artwork but agrees not to use the submitted design for any commercial purposes without the prior written consent of the Organizers.

3.3. The winning designs may be used by the Organizers in any media, including but not limited to social media, websites, and promotional materials, with proper attribution to the designer.

3.4. The Organizers have the exclusive right to apply the winning designs to Pierre Gasly's helmet for the specified races.

# 4. Judging and Announcement

4.1. The judging panel will be composed of representatives from Qatar Creates, Pierre Gasly, and industry experts in design and motorsport.

4.2. Designs will be judged based on creativity, originality, relevance to the cultural theme of the selected city, visual impact, and practicality for use on a racing helmet.

4.3. The decision of the judging panel is final and binding. No correspondence or discussion regarding the judging process or results will be entertained.

4.4. The winners will be notified by email within a week of the submission deadlines.

# 5. Liability

5.1. The Organizers will not be responsible for any late, lost, misdirected, or incomplete submissions due to technical or other reasons beyond their control.

5.2. By participating in the Competition, participants agree to release and hold harmless the Organizers, their affiliates, and their respective officers, directors, employees, and agents from any and all liability arising from or in connection with the Competition, including but not limited to claims relating to copyright infringement, defamation, or invasion of privacy.

5.3. The Organizers will not be liable for any injury, loss, or damage of any kind resulting from participation in the Competition or from the acceptance or use of any prize awarded.

### 6. Privacy

6.1. Participants' personal information provided in connection with the Competition will be used by the Organizers solely for the purposes of administering the Competition and will not be shared with third parties without the participant's consent.

6.2. Participants agree that the Organizers may use their name, likeness, and biographical information for promotional purposes without additional compensation, except where prohibited by law.

### 7. Governing Law

7.1. These Terms and Conditions are governed by and construed in accordance with the laws of the State of Qatar.

7.2. Any disputes arising out of or in connection with the Competition shall be subject to the exclusive jurisdiction of the courts of Qatar.
